WHEREAS, Sections 35214, 17566, 17567, 81602, and 81603 of the Education Code authorize a school district or charter to establish insured and self-insurance plans for workers' compensation, property and liability, miscellaneous property or any other risk or plan authorized by law;			
WHEREAS, the Barona Indian Charter School is a member of and has executed an Articles of Agreement to the San Diego County Schools Risk Management Joint Powers Authority (JPA) & the JPA Agreement requires that the Board of member districts/charters designate & appoint a JPA representative.
